## MultiTrans 7 Patch 7.0.21322.1 - 7.0.22027.1.0

#### **New Features**

- 1. (4020) A new business intelligence (BI) module is available, based on Microsoft SQL Server Reporting Services (SSRS). A new page is available through which the reports are accessible. The reports included in this release are selected from the most used reports in the legacy reporting module:

- 2. (4090, 4100) The new reports can be made available through the Customer Portal and filter automatically to only include information for the relevant customer.
- 3. (4099, 4101) The new reports can be made available through the Provider Portal and filter automatically to only include information for the relevant provider.
- 4. (68186) The project group name has been added to the getProjectDetails response.
- 5. (66168) A new type of Fixed Amount contracts has been added, based on the number of weighted words a provider can be assigned.
  - a. (68144) Once a task has been added to a contract, the contract type (Fixed or Open) and the contract unit (currency or weighted words) cannot be changed.
  - b. (68591) The contract unit (currency or weighted words) displays in the Contracts tab of each project in the Project Manager Portal.
  - c. (66174) An appropriate weighted words contract can be automatically linked to a task assigned to a provider.
- (66169) A new option to Validate Provider's Daily Capacity is available in System Parameters > Contract.
  - a. (66170) With this option enabled, the Provider Search function must be used to assign external providers to a workflow task.
  - b. (66171) With this option enabled, Project Managers must actively confirm their intent to assign a task to a provider that exceeds their daily capacity.
  - c. (66172, 66173) An Availability Check has been added to the Provider Search, which validates the task size in relation to the provider's availability and suggests a suitable contract.
- 7. (70198) The Show Workload option in the Project Manager portal has been replaced by a direct link to the Provider Scheduling.

- 28. (67486, 68316) Rich text is limited to 2000 characters when entering Instructions and Comments from the Customer Portal.
- 29. (73352) The steps to download invoices from the Customer Portal are identical regardless of how the invoice was created.
- 30. (73379) The project creator is added to the Also Deliver To field when cloning a project in the default Project Creation Form (PCF).
- 31. (67513) The delivery time is properly indicated when no time has been selected in the default PCF.
- 32. (64551) A clear error message is displayed when the delivery time is earlier than the current time on today's date.



- 33. (73607) No errors are logged when completing an Offline Review from the Customer Portal.
- 34. (58539) No error occurs when deleting a target file from a task in Flow.
- 35. (67950, 73594) Descriptive error messages are displayed if a task cannot be added to a contract for a valid reason such as insufficient funds, no rates defined, or no units selected.
- 36. (68926) The Amount Paid on a provider's contract accurately reflects the provider's invoice when there are multiple units in an invoiced task.
- 37. (68927, 69192) Long contract names or numbers as well as purchase orders, display correctly in the Contract Management area of the Project Manager Portal.
- 38. (69188) Long contract names or numbers display correctly on the Contract tab of a project.

- 45. (69797) A maximum of 50,000,000 has been introduced for any field value in a contract.
- 46. (73591) If the Allocated Amount of a contract is removed, it is reset to 0.
- 47. (69800) The Remaining Amount of a contract is recalculated each time the contract is modified.
- 48. (68659) Assigning a contract to a provider task takes fewer clicks.
- 49. (69446) A clear error message displays when attempting to assign a task to a contract, when the task total amount is greater than the contract remaining amount.
- 50. (68823, 69107, 69177) User interface updates have been made to the Provider Search.
- 51. (69291, 69720, 69724) One or more providers can be added without error to a static workflow task in a project.
- 52. (73872) Project Managers can select a due date in a different year by using the drop-down list when creating a new project.
- 53. (69843, 73394) Project Managers can save their inline edits when removing a provider from a task and later add a new provider.
- 54. (73452) A second provider assigned to a task can be modified rather than removed and re-
- 55. (70010) The tooltips have been corrected when assigning providers to tasks in the Project Manager Portal.

- 57. (69919) The calendar icon for adding a task delivery date in a project displays correctly.
- 58. (68029, 68940) There is proper error handling when multi combo fields are left blank when creating a project from the Project Manager Portal.
- 59. (73699) Updated unit types are reflected correctly when creating invoices from the Project Manager Portal.
- 60. (73700) The sample Provider and Customer CSV import files have been updated.
- 61. (69940) Target languages are not duplicated when importing providers from CSV files.
- 62. (70059) The selected delimiter is used when exporting providers to CSV files.
- 63. (61715) The 5-day view of the provider schedule, when crossing a weekend, has been properly aligned for clarity.
- 64. (69739) The provider schedule display does not shift unnecessarily when entering a time period from 0:00 to 0:00 in a day.
- 65. (69837) Long provider names display correctly on the provider schedule.
- 66. (69840) Custom colours can be used in the provider schedule.

- 79. (67914) When creating a new provider, the default currency is saved without requiring explicit selection.

- 87. (66720, 66918) Additional error handling has been added to the custom invoice creation feature.
- 88. (68312) No errors are logged when the custom invoice template service has not been installed.
- 89. (67760) Project Managers cannot select invoice languages when creating custom invoices.
- 90. (73347, 73348, 73470) Some alignment and display issues have been corrected in the Invoice section of the Provider Portal.
- 91. (64295) Providers can complete tasks that have been accepted, deleted, and then recreated.
- 92. (69428) In the Provider Portal, invoices can be ordered by invoice number.
- 93. (73483) The Provider Portal displays the schedule in the provider's selected time zone.
- 94. (64711) The level of effort is calculated when a provider selects a task from a pool.
- 95. (68143) The level of effort is calculated when a second provider is added to a single task.
- 96. (70057) A proper error message displays when two or more Timesheet events overlap.
- 97. (54808) Valid analysis results are returned for documents containing empty strings.
- 98. (66510) Analysis results are returned for Word documents with tracked changes only partially enclosed within <w:ins> tags.
- 99. (60888) Weighted words are updated when the Global Analysis is run on a project.
- 100. (69630) Document analysis information is deleted when the corresponding workflow is removed.
- 101. (58290) Documents with names ending in underscores (\_) can be downloaded following processing by Flow Machine Tasks.
- 102. (66717) XLIFF files no longer grow extremely large when hidden Unicode characters are automatically propagated.



- 103. (64653, 65239) When an invalid XLIFF file is part of an Update TextBase job from Flow, any valid files in that job will be added to the TextBase rather than the update failing.
- 104. (69115) ODS files with nested tags roundtrip successfully between MultiTrans and Trados Studio.
- 105. (69526) Extra tags do not appear in Trados Studio when ODS files are opened through the MultiTrans Trados Studio connector.
- 106. (73432) Word documents containing DrawingML schemas roundtrip successfully between MultiTrans and Trados Studio.
- 107. (69725) Word documents with nested segments roundtrip successfully between MultiTrans and Trados Studio.
- 108. (73651) MultiTrans notifies users when the package received by Trados Studio does not contain the processed file.
- 109. (70063) Word documents roundtrip correctly with Trados Studio after modifying tags in the Web Editor.
- 110. (69370) Inline tags representing WordProcessingML in Excel files are properly converted to XLIFF tags.
- 111. (68617) Autotext hyperlinks are extracted from Word documents for translation.
- 112. (68675) Word documents with custom XML open without error on export.
- 113. (68850) A specific combination of clicks between source and target segments in the XLIFF Editor no longer modifies the text in the target segment.

- 145. (61704) Customer-specific archive jobs are cleaned up correctly in the database and do not output error messages to the logs.
- 146. (60723, 66706, 69120, 70088, 70089, 73444, 73446, 73698, 74157) Some unnecessary messages have been removed from the Flow logs.

The legacy reporting module remains available. You may note some differences between data collected in the legacy reporting module and the new business intelligence module, as the new module has been optimized and has different search parameters.
